To all prospective candidates:

- 1. Candidates for the elected board seats on the Greater Mattapan Neighborhood Council must be residents of Greater Mattapan and must be at least 16 years of age and be eligible as described in the GMNC By-Laws.**
- 2. A minimum of twenty-five (25) signatures from eligible Greater Mattapan residents are required to secure a spot on the ballot for the election by April 30, 2021. MUST include printed names, addresses and signatures. Electronic signatures are permitted.**
- 3. Any Greater Mattapan resident 16 years of age or older may sign nomination papers.**
- 4. Completed nomination papers must be signed by the candidate and brought in person to Café Juice Up, and placed in lock box by April 30, 2021:**


